Young Professional: Brad Bujan provided an update on past social events and asked if any members are interested in the YP in the Valley area to please speak with him.


Website: Erin Newberry reminded all present to visit the chapter website to stay current on events and announcements.


Chapter Door Prizes and Raffle: Christie Saenz, Denise Skinner and Matt McGee presented the raffle items to attendees.

Adjourn: The meeting was adjourned by Erin Newberry at 1:02 p.m.




